DAF Meets Growing Demand for Sports Scholarships

The Double Angel Foundation was pleased this year to meet a growing need for youth baseball and softball scholarships throughout the metro area, awarding \$6,317 to nine individuals and Parker Youth Sports.

In a year that marked 20 years since the tragic passing of Dillon and Logan Dixey, it seems appropriate that some of this year's recipients had heard about the brothers, for whom the scholarships were created, from a very young age.

The largest scholarship was awarded to Ponderosa High graduate **Ty Martens**, 18, who received a \$1,000 scholarship to Northwestern College.



Baseball means a lot to Ty: "The love of the game and competition are two great things, but people and the relationships you form with them will last a lifetime, long after the cleats have been hung up."

Parents Katie and Sam Martens said Ty "was at the dedication ceremony of the (Double Angel) fields when he was just 4 years old and grew up hearing the story of Dillon and Logan."

Ponderosa's **Brady Ingalls**, 17, who received a \$500 scholarship, also had known about the Dixey boys from a very young age, growing up in the same area of Parker. Mother Ginger

Ingalls said he "will uphold the legacy you all have started for your boys."

Parker Youth received a \$4,000 donation, which was used to purchase equipment and buckets of baseballs and softballs for all of its 60 teams.

Gameday Sports received a \$5,000 donation that will be used to help operate the Double Angel Ballpark.

The Double Angel Foundation received thank you notes from most of the individuals who

received scholarships this year, as well as from the Colorado Bombers 14u Majors and the Parker Hawks for the practice balls and buckets that were donated.

Depending on financing and grants, the Foundation annually awards scholarships to ballplayers between the ages of 5 and 18, who need financial assistance. Scholarships can be used for high school baseball, special needs and community baseball programs, and girls' softball.

Carbon Monoxide Poisoning Discussed at Annual Boating Convention

The story of Dillon and Logan Dixey and the dangers of carbon monoxide poisoning were highlighted at this year's annual conference of the National Association of State Boating Law Administrators.

During the virtual conference, Colorado Boating Safety Program Administrator Grant Brown shared information about the Dixeys, as well as the Double Angel Foundation and its efforts to make the public aware of carbon monoxide while boating.

Brown shared DAF's letter, in which the Foundation successfully requested putting

carbon monoxide warning information on Colorado's boating regulations brochure, in hopes that other states would follow suit and get the warning "out to the masses."

He plans to present similar information to the Western Boating Association in January. He is also working with DAF on other ways to promote safety, including a warning sticker.

During the fall virtual conference, carbon monoxide information was also presented by Minnesota Recreation Safety Outreach Coordinator Lisa Dugan. Minnesota passed Sophia's Law, which took effect on May 1,

2018, and requires motorboats with an enclosed accommodation compartment to be equipped with a functioning marine CO detector.

The law was named for 7-year-old Sophia Baechler, who died from carbon monoxide poisoning while boating on Lake Minnetonka.

Our Gameday 2020 youth season has come to an end. Despite the lack of tournaments due to COVID-19, all of our youth teams got in a lot of baseball.

The youth season began in January with our customary two practices per week. The first was a “Gameday-led” practice, featuring several professional players who worked with players to improve their fundamentals and knowledge of the game. The second weekly practice was implemented by our youth coaches. It was an awesome January-March.

Then, the pandemic.

How did we handle the crisis and unrest amongst our Gameday players, parents and coaches? We immediately waived all remaining Gameday fees, essentially making our 2020 youth fees 50% off. We knew people were struggling, each in their own way, and we made the right decision even though our own company was in financial turmoil. We firmly believe putting our players and their needs first is the only way to manage our business.



During the quarantine period, we offered two Zoom calls per week for all players, coaches and parents. The first weekly call focused on drills and activities our players could do at home to stay in “baseball shape.” The second call featured a special guest. The highlight was hearing from Dave Dravecky, a former major league player and fellow Christian who has a powerful and motivational story. Our next

guest was current Colorado Rockies catcher Tony Wolters. Our players had fun getting to know Tony and hearing his story.

When Colorado issued the first phase of “Safer-at-Home,” we were able to continue team practices, adhering to all social distancing guidelines and precautions. Baseball was back for Gameday players! Once the second phase of “Safer-at-Home” was put in place, we were able to have make-shift scrimmages among our teams from May through July.

Despite the adversity, we were able to provide a solid baseball program to all of our teams and players in 2020. We are blessed to have awesome indoor facilities and the Double Angel fields that allowed our players to play baseball when many neighboring fields were closed.
